10 May 21, 2010: Last day for Calix to file/serve Opposition to Motion to Dismiss/Transfer;

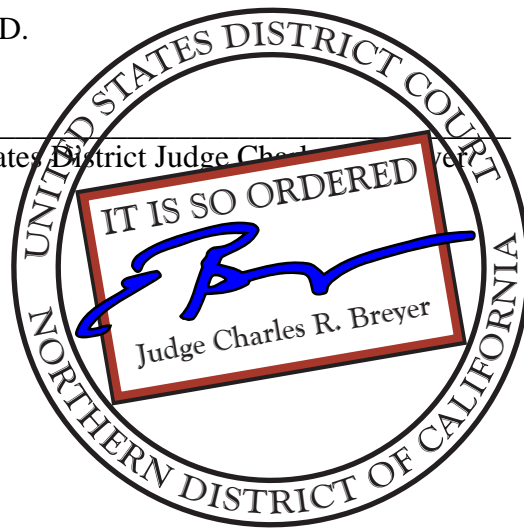
11 May 28, 2010: Last day for Wi-LAN to file/serve Reply brief in support of Motion to
