1 Pursuant to Civ. L.R. 7-11, Defendant Wi-Lan Inc. (“Wi-LAN”), by and through its
2 counsel, respectfully moves to continue the Case Management Conference (“CMC”), currently
3 scheduled for April 2, 2010, to April 30, 2010, at 10:00 a.m., which is when the Court is scheduled
4 to hear Wi-LAN’s Motion to Dismiss for Lack of Personal Jurisdiction (Dkt. No. 17). Wi-LAN
5 believes that it would be in the interests of the Court and the parties to hold both hearings at the
6 same time, and also believes that holding the CMC on April 2 would be premature given the
7 current posture of the case, while the Court considers Wi-LAN’s Motion to Dismiss.

8 Counsel for Wi-LAN attempted to gain consent from Plaintiff Calix Network Inc.

10 concurrently filing a declaration that sets forth the facts surrounding his attempts to gain Calix’s
