



1 Pursuant to Civil Local Rules 6-2 and 7-12, Defendant Wi-LAN Inc. and Plaintiff Intel
2 Corporation hereby request amendment of the First Patent Scheduling Order; Notice of Intent to
3 Appoint a Special Master (Dkt. No. 226), dated September 3, 2009 pursuant to the instructions of
4 Special Master Denver following his recent discussions with the Court to approve these dates,
5 and pursuant to the Court having established the Markman tutorial date for May 27, 2010, and
6 the Markman hearing for May 28, 2010. Specifically, the parties seek amendment of Section C
7 of the Order so as to extend the time for Wi-LAN to serve its Patent L.R. 3-1 Infringement
8 Contentions for the “Adaptive Allocation” patents (as defined in the First Patent Scheduling
9 Order) until April 2, 2010 and to extend the time for Intel to serve its Patent L.R. 3-3 Invalidity
10 Contentions for the “Adaptive Allocation” patents until May 6, 2010.

11 Accordingly, concurrently filed herewith is the parties’ Joint Stipulation to Amend the
12 First Patent Scheduling Order; Notice Of Intent To Appoint A Special Master and corresponding
13 Declaration. In accordance with the Court’s and Special Master’s instructions, the parties are
14 meeting and conferring on a schedule for Markman disclosures and briefing leading up to the
15 May 27 Markman tutorial and May 28 Markman hearing.
